

Halton Housing have completed a tendering exercise to establish a national contract hire and flexi-hire framework agreement covering cars, light commercial, heavy commercial and specialist vehicles up to 44,000kg GVW.

This the fourth iteration of this widely trusted framework and has been procured with a heavy emphasis on the fleet requirements of housing associations and other public bodies. The three previous iterations in 2008, 2012 and 2016 are regularly used by over 250 eligible bodies.

This extensive framework is available for wider use by other Registered Social Landlords, plus Local Authorities, NHS Trusts, Police Authorities, Fire Authorities, Leisure Trusts, Registered Charities, Schools, Universities and Colleges. The framework consists of 4 different lots. We trust this is of assistance and benefit to your organisation.
